

May Speaker: Jerry White, Jr. – "Restoring the Snake River for Salmon and People"

The Working Snake River (WSR) Project promotes a thoughtful, comprehensive solution to restore wild Snake River salmon that benefits farmers, fishermen, local communities and the Inland Northwest economy. The project reaches out to businesses, sportsmen, farmers, conservationists and citizens committed to restoring Eastern Washington's lower Snake River corridor and endangered wild salmon by replacing four aging and costly dams with modern transportation and clean energy alternatives.



Removing the four lower Snake River dams will restore more than 60 rapids and 30,000 acres of parklands, wildlife habitat and public access. Increased fishing, tourism and recreation along with transportation and energy investments will provide jobs, improve quality of life and expand local economic opportunities. The WSR presentation also includes a remarkable set of photos that show the river in its healthy, free-flowing state prior to 1975. These photos point the way in creating a Northwest supported by sustainable jobs, recreational opportunities and a high quality of life for future generations.

Save Our Wild Salmon is a coalition of sport fishing groups and businesses, conservation organizations, commercial fishermen, clean energy advocates, taxpayer groups and others working to restore wild salmon and steelhead to the Columbia and Snake Rivers.

Jerry has been with Save Our Wild Salmon since May of 2008, and he is principally involved with the Working Snake River Project. Born in Corvallis, Oregon, he was raised in Eastern Washington and received his undergraduate degree in anthropology from Western Washington University. Jerry worked as an archaeologist for the US Forest Service and the Bureau of Land Management and then taught history and English in middle school for 12 years before taking a position with Save Our Wild Salmon. Jerry is a Trout Unlimited volunteer with the Spokane Falls Chapter and passionate about the conservation of salmon, steelhead and trout. He feels that clean rivers and healthy fish populations contribute to a high quality of life for the communities that live with them.

Fishing Reports

Kay Youngblood reported that she and her husband Lynn had recently fished below the dam on the Owyhee. They fished some fairly quiet water and tried small stuff, but when they switched to big attractors, they started to catch fish. They caught 15 fish in the 20 to 24 inch range!

Mike Decker fished the Clearwater, where he turned a number of fish before discovering his hook was broken. Dave Tharp fished Amber Lake, where he was skunked in the weed beds at the south end, but hooked about eight and landed half in other parts.

Doug Young fished the Tucannon Ponds, doing well on a Wooly Worm, and then switching later to a small Mepps. Gerry Vidergar did some steelheading on the South Fork of the Clearwater, getting about 20 in the week, with some in the 20 plus pound range, but with bad weather most of the time.

Conservation Report

Cliff Swanson and Nancy Miller attended the public meeting on the proposed land swap between the Forest Service and Western Pacific Timber, which was held this same night in Moscow. Steve Bush tried to get in, but the room was overcapacity when he got there. The formal public comment period was reported to be over, and this was intended to be an informational meeting run by the Forest Service with Latah County Commissioners in attendance. It was obvious that the vast majority of attendees were opposed to this swap, and that there is a lot of controversy about it in this region of the state. The Forest Service will still accept and consider written comments about this matter. There seems to be little doubt about the importance of the swap relative to improving the lands the Forest Service would receive in the Upper Lochsa Drainage, however, there are many reasons people object to the lands being proposed by the Forest Service in the Idaho Panhandle Region falling into private hands. There are important recreational lands directly involved, and others that would become less desirable if heavy timbering were to occur on adjacent lands. There are rare plants on other lands, and questions are being raised about potential development after the timber is removed. (continued on page 3)

Five Rivers Lodge Sweepstakes

The Federation of Fly Fishers is holding their **Five Rivers Lodge Sweepstakes**, with the drawing scheduled for June 20, 2009, at the Conclave in Loveland, Colorado.
